hereby issues the following provisions:





Art. 1 – General Provisions

Vocal students who will complete their Erasmus mobility period at the "Cesare Pollini" Conservatory of Music in Padua by July 2025 may apply for the selection of the roles of Fiordiligi and Dorabella for the reserve cast of the audiovisual production of *Così fan tutte* by Wolfgang Amadeus Mozart. The production will take place after the end of their Erasmus mobility and by December 2025. Selected candidates will receive a short-term mobility grant funded by the Italian PNRR. **The amount of the mobility grant will be referred to the Italian national provisions relating to the mobility of the Erasmus Programme, Call 2025**.

Art. 2 – Application Procedure

Candidates must submit their application (attached to this call) via email to: international@conservatoriopollini.it by no later than 11:59 PM on 11th May 2025.

The application must include a file containing the video link(s) in which the candidate performs pieces from the Mozart repertoire or similar.

Art. 3 – Candidate Selection Procedure

The Selection Committee will be composed of three faculty members appointed by the Director of the Conservatory of Padua. The committee will assess the technical and interpretative quality of the submitted video performances.
